

## Retrieving SEC No-Action Letters

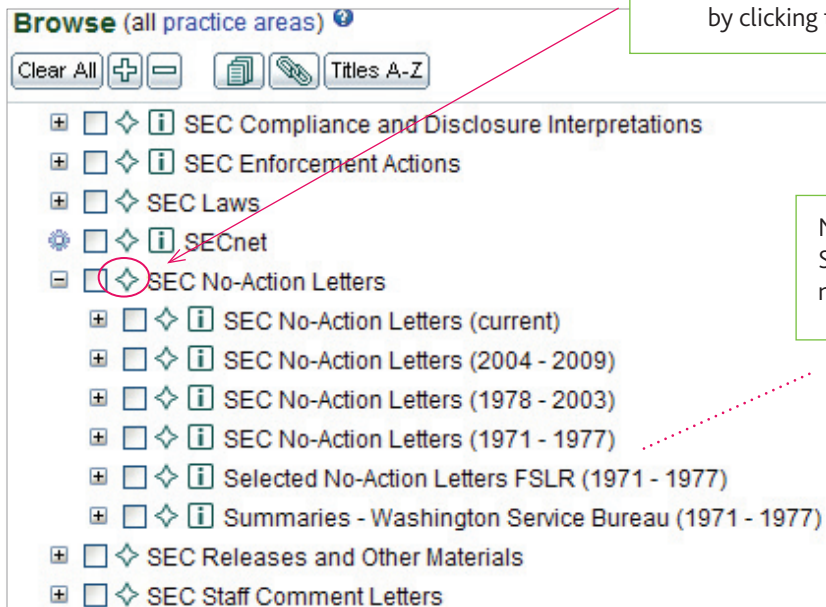
You can retrieve SEC No Action Letters by searching for keyword, company name, law firm name, date, the law/reg/rule that the NAL concerns, or a combination of these.

### How to get there

1. Go to: <http://intelliConnect.cch.com>
2. Open **Practice Areas** and confirm that "Federal" (within "Securities") is available and selected. Click **Apply** (and **OK** to save changes, if needed).



3. Locate the SEC No-Action Letters database:



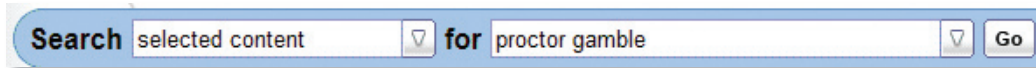
**TIP:** For quick access in the future, add **SEC No-Action Letters** to **My Favorites** by clicking the diamond

**NOTE:** The complete archive of SEC No-Action Letters contains material back to 1971.

## Searching for SEC No-Action Letters (NALs)

**Search for company name:** e.g., Procter & Gamble

- Check the box(es) for SEC No-Action Letters. Note: Search scope should read “selected content”
- In the search text field, type company name and click **Go**



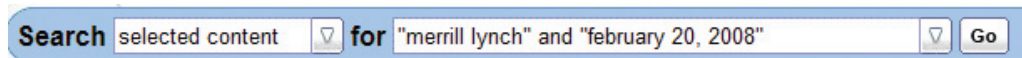
Search selected content for procter gamble Go

**TIP:**

- Results are displayed by relevance. NALs with your search term(s) in the title will be at the top.
- Change the display to show results in reverse chronological order by clicking **Most Recent**

**Search for name and specific date:** e.g., Merrill Lynch, February 20, 2008

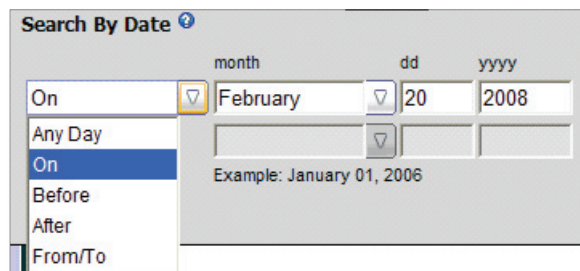
- Target SEC No-Action Letters
- Type the name of the company in quotes and the date in quotes and click **Go**



Search selected content for "merrill lynch" and "february 20, 2008" Go

*This will find all documents containing both the company name and the date as phrases within the text of the document*

**TIP:** You can also use **Advanced Search** to restrict the search to specific dated documents.



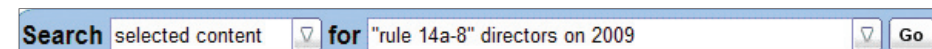

**Search for NALs dealing with a particular rule and add key words and date:** e.g., Rule 144

- Target SEC No-Action Letters
- Type the rule in quotes and, if desired, add a word and a date:

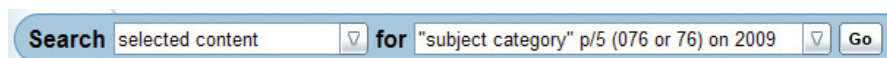


Search selected content for "rule 14a-8" directors on 2009 Go

**Search by category:** Include subject category number(s) to locate NALs pertaining to the same topic. For example, Rule 14a-8 is broken down as follows:

- Category 73: Timely submissions
- Category 74: Other procedural exclusions
- Category 75: Substantive exclusions: exec. comp.
- Category 76: Substantive exclusions: director elections
- Category 77: Other substantive exclusions

## SEC No-Action Letters List of WSB Subject Categories
