



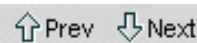

Login	<p>http://intelliconnect.cch.com</p> <ul style="list-style-type: none"> Subscriptions are flat-rate annual charge. There is no additional charge for time spent online, searches conducted, documents downloaded/printed or emails sent. Check the box(es) to remember your User ID and password and login automatically 	
Content	<p>You will only see content within your firm's subscription. It is not possible to access content beyond what is included in your subscription.</p> <p>Titles A-Z  —View/locate titles within alphabetical listing of subscription contents.</p>	
Customization	<p>Practice Areas—Focus content available for researching, e.g., Federal Tax or Securities</p> <p>My Favorites—Click  to add an item within the Browse menu to My Favorites</p> <p>Preferences—Change settings for search, documents, printing, exporting, etc.</p> <p>Research Folders—Create folders to save links to selected documents</p> <p>Tracker News:</p> <ul style="list-style-type: none"> 'Sign up for E-Newsletters/Report Letters'—Each letter sent separately.
